# **Reservation Terms**

Reservation Terms of Neura Robotics GmbH for the household robot - MiPA

# 1. Subject of Reservation

By paying EUR 100 incl. VAT ("**Reservation Fee**") you secure the opportunity to purchase the Neura Robotics household robot MiPA, which currently in development, at an expected price of EUR 9,999 plus VAT once MiPA is available (availability is planned for end of 2025). The reservation does not constitute a binding purchase agreement and does not oblige either you or us to enter into a purchase agreement. The reservation merely gives you the opportunity to purchase MiPA on a priority basis, whereby reservations received earlier will always take precedence over reservations received later.

# 2. Refund & Application

The Reservation Fee is:

- fully refundable upon your request at any time before an actual order is placed by you for MiPA.

- offset against the purchase price if a purchase agreement for MiPA is actually concluded between you and us.

### 3. No Delivery Obligation

The reservation secures you a preferred position in the production and delivery queue, provided that you decide to purchase MiPA and a purchase contract is concluded between you and us. However, the reservation does not commit us to deliver MiPA, nor do we promise a specific delivery date.

# 4. Purchase Option & Order Process

Once MiPA is available, we will notify you via email. You will then have the opportunity to convert your reservation into a binding order. A final purchase agreement only comes into effect once you have submitted an order and we have accepted your order.

5. Cancellation of Your Reservation

7. Governing Law. Place of Jurisdiction

a) The following applies to reservations made by consumers:

(1) Subject to mandatory provisions of international private law, the reservation is governed by the laws of the Federal Republic of Germany, excluding the UN Convention on Contracts for the International Sale of Goods. If you have your habitual residence in another country, you retain the protection afforded by the relevant provisions of your country of residence, from which no deviation may be agreed.

(2) If, at the time of making the reservation, you had your place of residence or habitual residence in Germany and have either moved from Germany by the time we file a lawsuit or your place of residence or habitual residence is unknown at that time, the place of jurisdiction for all disputes shall be our registered office.

b) The following applies to reservations made by entrepreneurs:

(1) The reservation is governed exclusively by the laws of the Federal Republic of Germany, excluding international uniform law, in particular the UN Convention on Contracts for the International Sale of Goods, and excluding international private law.

(2) The exclusive place of jurisdiction for all disputes arising directly or indirectly from or in connection with the reservation is our registered office.
